BECOMING A JP

To become a JP in Queensland you must complete either

10794NAT Course in Community Justice Services (Justice of the Peace [Qualified])

OR

 10793NAT Course in Community Justice Servies (Commissioner for Declarations).

QJA is an RTO delivering the course (Registration no 31906) which can be undertaken online (self-paced) or in a classroom (2-3 days weekdays or weekends).

Appointment depends on eligibility. Scan the QR Code to find out more about eligibility.

On successful completion, students apply to the Department of Justice and Attorney-General for appointment.

Appointment in Queensland is for life unless you become ineligible.

- Statutory Declarations
- Affidavits
- Certify Copies
- Wills
- Powers of Attorney
- Land Titles Documents
- Other documents where prescribed

A Justice of the Peace (Qualified) can perform the above and judicial duties such as:

- Issuing summonses
- Issuing arrest and search warrants
- Attending records of interview
- Hearing Bail Applications
