1. The organising committee reserves the right to change this program at any time & prizes/prizemoney.
2. Refunds: A 50% refund will be given for stabling & entries only on sighting a doctors or veterinary certificate. 100% refund will be given if the scratching is before the closing date.
3. Entry Changes: **No new horse entries will be accepted after the closing date.** No changes will be accepted after 5pm the previous day.
4. All placegetters MUST present for prizes mounted, or prizemoney is forfeited.

5. Cancelling of Event: If the event is cancelled prior to its commencement 90% of all entries, stabling & camping moneys will be refunded.
6. Protests: In the event of a dispute, the QCAS rules shall apply. The Chief Stewart shall have the power to ban from competition any competitor whose behaviour to an official, steward and/or volunteer is considered offensive by the Judge or Chief Stewart. Persons must lodge protests with \$100 (inc GST) bond in writing to the Secretary which will be forfeited if the protest is turned down and refunded if protest is upheld.
7. All prizes and prize money are to be collected from the Head Steward by Sunday, 11th May 2025 (or as per any other arrangement made directly with the Head Steward). After this time, any unclaimed prizes will be dealt with in accordance with legislative requirements. At all times, it is the sole responsibility of the winner to collect his or her prize.

I AGREE TO ENSURE THAT PRIOR TO ARRIVAL:

1. All horses will be shampooed, rinsed and allowed to dry, and their hooves will have been picked clean of all solid material and washed with shampoo.
2. All vehicles and equipment accompanying the animals will be cleaned to remove all solid material that could contain disease agents, and then disinfected.

I FURTHER DECLARE THAT:

3. The information contained in this Biosecurity Declaration and Movement Record is true and correct to the best of my knowledge.
4. I agree to abide by all conditions that may be imposed at any time by the Event Organising Committee/Manager. I also agree to abide by and accept the regulations as printed in the schedule and make these entries subject to such regulations and rules of the committee.

5. I acknowledge that in failure to comply, I may be directed to leave and my nominations will be forfeited.
6. I acknowledge that decontamination and disinfection procedures may be required of me if instructed by the Event Organising Committee/Manager.
